As a partner with the local church, Journey exists to impact lives by providing biblical counseling through compassionate and competent counselors who facilitate transformation through the power of the Gospel of Christ.

How We Began...

Journey Counseling Ministries opened its doors in 2008 with the purpose of serving and ministering to Harrisonburg's local churches as well as the individuals and families in the greater community. Our ministry's founder, John F. Kuebler, envisioned Journey to bear specific qualities, which still hold true today.

Of these qualities, first and foremost is a foundation based upon Jesus Christ and Biblical principles and standards; therefore, all of our therapists are both biblically based and clinically trained. All of our clinicians are formally trained from accredited seminaries, colleges, and universities. Journey is a not-for-profit (501(c)3) organization and is overseen by a Board of Directors.

What We Believe

At Journey, our counselors and therapists are biblically based and clinically trained. We provide counseling through the lens of Scripture and in conjunction with current psychological standards and research. We believe the Holy Bible is the foundation that guides, counsels, and instructs us as we serve and support you, people of all ages, ethnicities, and through different stages of life.

Our Board of Directors, counselors, and staff are in agreement with the Westminster Confession of Faith, and each is committed to active participation in a local church and in the working of Christ in their personal sanctification; so that they can authentically walk alongside others in their faith journeys.

All of us receive weekly group supervision. Our therapists fulfill requirements for continuing education to maintain licensure; Each regularly attends professional development training in our fields of interest and especially in counseling ethical standards.

Partnership

Journey Counseling Ministries partners interdependently with pastors and their churches to provide support and professional care. We see several levels of partnership that could be established for the mutual benefit of churches and Journey Counseling Ministries:

1. Partner in Prayer

a. Sign up for our newsletter to receive specific prayer requests for our ministry.

2. Become a Referral Base

- a. Journey desires to come alongside churches to aid their ministries and high calling to be shepherd, counselor, and comforter.
- b. We have enclosed a copy of the *Pastoral Cooperation Waiver form* for signature of pastor/elder and congregant so that we can communicate general information to support you in your shepherding role.

3. Provide Church-Funded Scholarships for Members Referred

- a. Church leaders are often acutely aware and overwhelmed by the need of their members and congregants for counseling services and want to ensure they are referring their people to a clinic that will support the work of the church and address counseling needs from a biblical perspective. A number of churches have partnered with Journey to provide full or partial payment for a number of sessions to decrease financial barriers to seeking counseling with us.
- b. The following is a list of current churches in which we have financial partnerships with: Covenant Presbyterian Church, Crosslink Community Church, Christ Presbyterian Church, Dayton Mennonite Church, Eastside Church, Faith Community Church, First Presbyterian Church on Court Square, Grace Covenant Church, Horizon Christian Fellowship, New Beginnings, Bethlehem Church, and Rileyville Baptist Church.

4. Become a Donor to our Client Assistance Fund (CAF)

- a. We have found that many people desire a place where they can integrate their faith with counseling, yet simply cannot afford it. Our desire is that counseling can be offered to all in need without money being a prohibitive factor.
- b. To make counseling more accessible, Journey established the Client Assistance Fund (CAF), which is a donation-funded/needs-based program that helps subsidize a number of sessions at a reduced rate. Clients seeking financial assistance through the CAF must complete a brief application, which is reviewed by our counselors and approved by the Clinical Director based on client need and availability of funds.

5. Community Engagement

a. Counselors may be available to provide trainings/seminars at your location on various relevant topics.

FAQs

Q: How do I set up an appointment?

To set up an appointment, please encourage your congregants to contact their counselor of choice directly via phone or email listed above or they can utilize the general phone: (540) 908-3464 and general email: journeycounseling@gmail.com and someone will call them back within 2 business days.

Q: What is the cost of counseling?

To see a licensed therapist, the rate is \$105 per session. To see a Resident in Counseling, the rate is \$90 per session. If we have an Intern, the rate is \$45 per session. We take cash, checks, MasterCard, Visa, and American Express. All payments are accepted at the **beginning** of each session. Please make checks out to Journey or JCM.

Q: Do you accept insurance?

No, we **do not** file directly with insurance companies, but we can help! If you see a licensed counselor, he or she can work with you to file a claim with your insurance company by providing the necessary receipts. *We do not work with Medicaid or Medicare. *

To see if your policy would provide reimbursement, please ask the following questions of your insurance company:

- *Do I have mental health insurance benefits?*
- Do I have marriage and family counseling insurance benefits?
- Does my insurance cover service for an "out of network" provider?
- What is my deductible and has it been met?
- How many sessions per year does my health insurance cover?
- What is the coverage amount per therapy session?
- Does my insurance require a licensed counselor?
- *Is approval required from my primary care physician?*

Q. Is Journey a crisis counseling center?

Journey Counseling is not a crisis counseling center. We provide services by *appointment only*. If you have an emergency, please contact your local emergency services, call 911, or go to the nearest emergency room.

MUTUAL COOPERATION WAIVER FOR PASTORS AND CHURCH MEMBERS

Journey Counseling Ministries was created with the understanding that Christians should have their spiritual and relational needs met within their congregation and that the responsibility for the care and cure of souls rest primarily on the local church body. Journey counselors see themselves as part of the body of Christ which is described in Paul's epistle to the Corinthians (1 Cor. 12) as having many members each with diverse calling and ministries. It is the goal of Journey Counseling Ministries to be interdependent, NOT independent, of the churches whose members are served by this ministry. Journey counselors provide pastoral and professional counseling for those whose church leaders may not have the time or expertise.

Therefore, the two parties listed below, agree to allow communication between the Journey counselor and the church (a pastor or ruler elder) in order to assist the members in ongoing shepherding and care. This communication will be general in nature so that any needed support, teaching, discipleship or accountability can be summoned from the client's congregation. Counseling information will remain confidential between member and counselor, but member will not be totally anonymous. This communication will also serve as mutual accountability between Journey and the local church. If there is any concerns about the biblical guidance given by the Journey counselor, we ask that it be addressed directly with Journey and the clients' pastor.

In order for this communication to occur, both client and pastor (or elder) must sign in the appropriate spaces below. This agreement will be valid unless cancellation by either party is requested in writing. NOTE: This agreement can only apply to church members, NOT visitors or attendees.
